### **Isle of Man Government Unified Scheme (Amendment) Scheme 2017**

In accordance with the Tynwald motion in June 2016 to reform public sector pension schemes, the Public Sector Pensions Authority (PSPA) is seeking your views on a proposed Isle of Man Government Unified Scheme (Amendment) Scheme 2017 which seeks to update the Isle of Man Government Unified Scheme 2011 (the Unified Scheme).

The consultation will run from 9 December 2016 and close at midday on 6 January 2017.

Tynwald has approved future cost savings to the Unified Scheme equivalent to 1.8% saving of Pensionable Pay.

As a consequence of these discussions the PSPA is proposing to make the following amendments to the Scheme:

#### For Active Members on 31 March 2017

- 1. Reduces pension benefits built up on or **after** 1 April 2017 by 6%; and
- 2. Increases member contributions by 2.5% phased in from 1 April 2018

#### For New Members on or after 1 April 2017

- 3. Benefit accrual reduced by 6%; and
- 4. A contribution rate of 7.5%; and
- 5. For Fire-fighters Membership of Section 7 with a contribution rate of 13.5%

It is important to clarify that this amendment does not seek to reduce the amount of pension benefit a member has built up for service to the 31 March 2017.
