

## Claim for an ARC Concessionary TV Licence Payment

### What is an ARC Concessionary TV Licence Payment?

An ARC Concessionary TV licence payment is a payment made to –

- a provider of sheltered housing; or
- a care home

to cover the cost of the concessionary TV licence payable for each eligible tenant or resident living in that accommodation.

### Who is an “eligible resident”?

There are 2 groups of people who count as an eligible resident –

- a) A person who, or whose partner, is aged 75 or over.
- b) A person who, or whose partner, has reached state pension age but not age 75 and is getting Income Support.

### What is Income Support?

Income Support is a Social Security benefit paid to certain people on a low income.

### When should a claim be made?

A claim can normally be made at any time from the date the TV licence fee is due until 3 months afterwards. For example, if your TV licence is due for renewal on 1 June 2017 you can claim your TV licence payment at any time between 1 June 2017 and 31 August 2017.

If the TV licence fee is due for renewal on any day in the period from 1 September 2016 to 30 April 2017 you can claim your TV licence payment at any time up to 31 July 2017.

### How to claim

Please provide the information requested overleaf together with the names and dates of birth of all your tenants/residents and their addresses (for each sheltered housing complex) or room numbers (for a care home) on the form provided and then send it with a copy of your new TV licence to: Income Support for Pensioners Unit, Social Security Division, Markwell House, Market Street, Douglas, IM1 2RZ.

An ARC Concessionary TV Licence Payment is payable for all “eligible residents” living in the accommodation you provide or manage.
