Thank you for your request dated 19th April 2017, to the Department of Education and Children seeking the provision of information under the Freedom of Information Act.

You asked:

*Further to the "Attainment in GCSE and Equivalent Qualifications Report 2016" published online at https://www.gov.im/media/1350181/2016_gcse_attainment.pdf and the DEC's response to Freedom of Information Request Reference Number IM80323I I write seeking further information namely: In respect of the academic years 2012-13, 2013-14, 2014-15 and 2015-16:- what percentage of pupils completing Year 11 at each island secondary school attained GCSE/IGCSE passes at grades A*C in all other subjects for which pupils were entered other than those that for which information was provided in the Department's response to FOI Request IM80323I (EBacc subjects), and for each secondary school, how many pupils completing Year 11 were entered for each of those "nonEBacc" subjects?*

1. Whether we have responded to your request for information in accordance with Part 2 of the Freedom of Information Act; or
2. Whether we are justified in refusing to give you the information requested.

In response to an application for review, the Information Commissioner may, at any time, attempt to resolve a matter by negotiation, conciliation, mediation or another form of alternative dispute resolution and will have regard to any outcome of this in making any subsequent decision.
