If you are in receipt of Income Support, a War Disablement Pension or are Registered Blind you are automatically entitled to a voucher towards the cost of **glasses**.

Dependant's Additions

These payments are made in addition to the basic rate of National Insurance benefits and some non-contributory benefits. For dependent children the additions have not been payable for new claims since 7th April 2003. Existing claims at that date continue in payment.

Dependent adult's additions

If your adult dependant lives with you, you will only get paid an addition if he or she earns less than the appropriate amount per week below:

With Retirement Pension, Long-term Incapacity Benefit, Severe Disablement Allowance and Unemployability Supplement:

Standard rate £73.10

With Carer's Allowance £38.90

With Short-term Incapacity Benefit:

- If you are over state pension age £62.75

- If you are under state pension age £50.80

If your dependent adult doesn't live with you the limits are:

With Retirement Pension £70.00

With Long-term Incapacity Benefit £65.20

With Severe Disablement Allowance £39.10

Dependent child's addition

Your dependent child's addition paid with long-term benefits will be affected if your spouse or partner lives with you and earns more than the following:

- for the first child £240.00

- for each extra child £32.00
