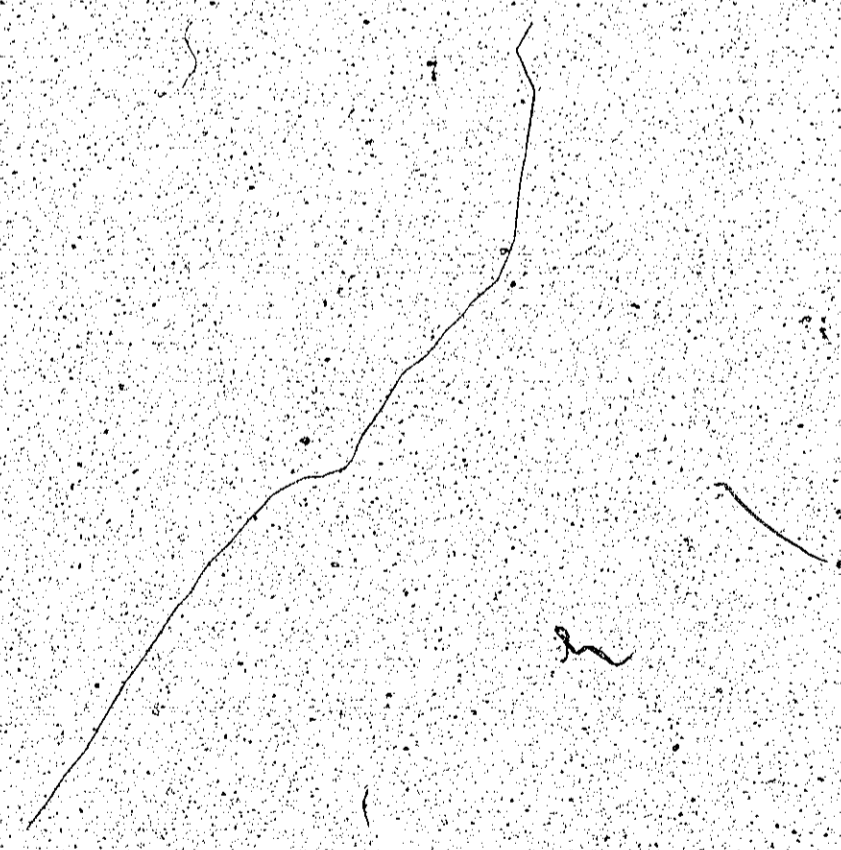
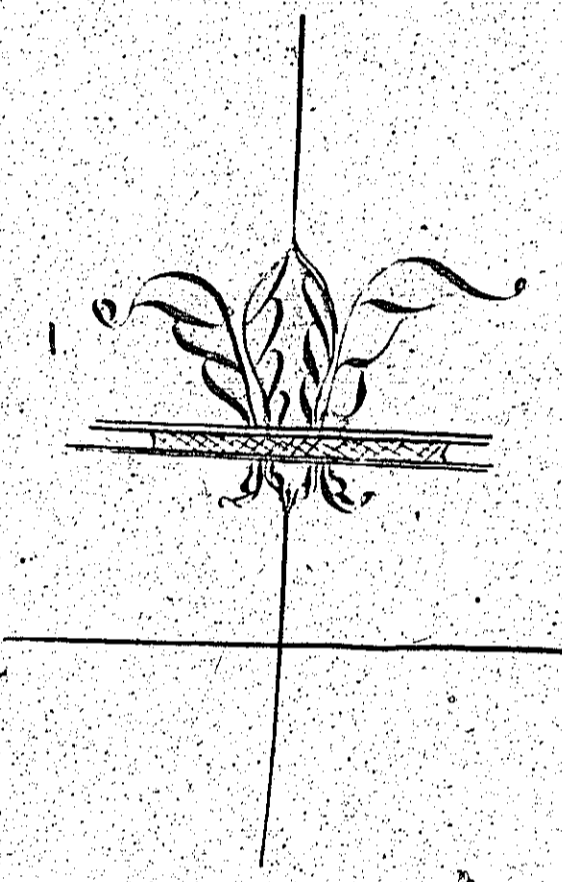


*Plan of Survey of the

 East Florida.*

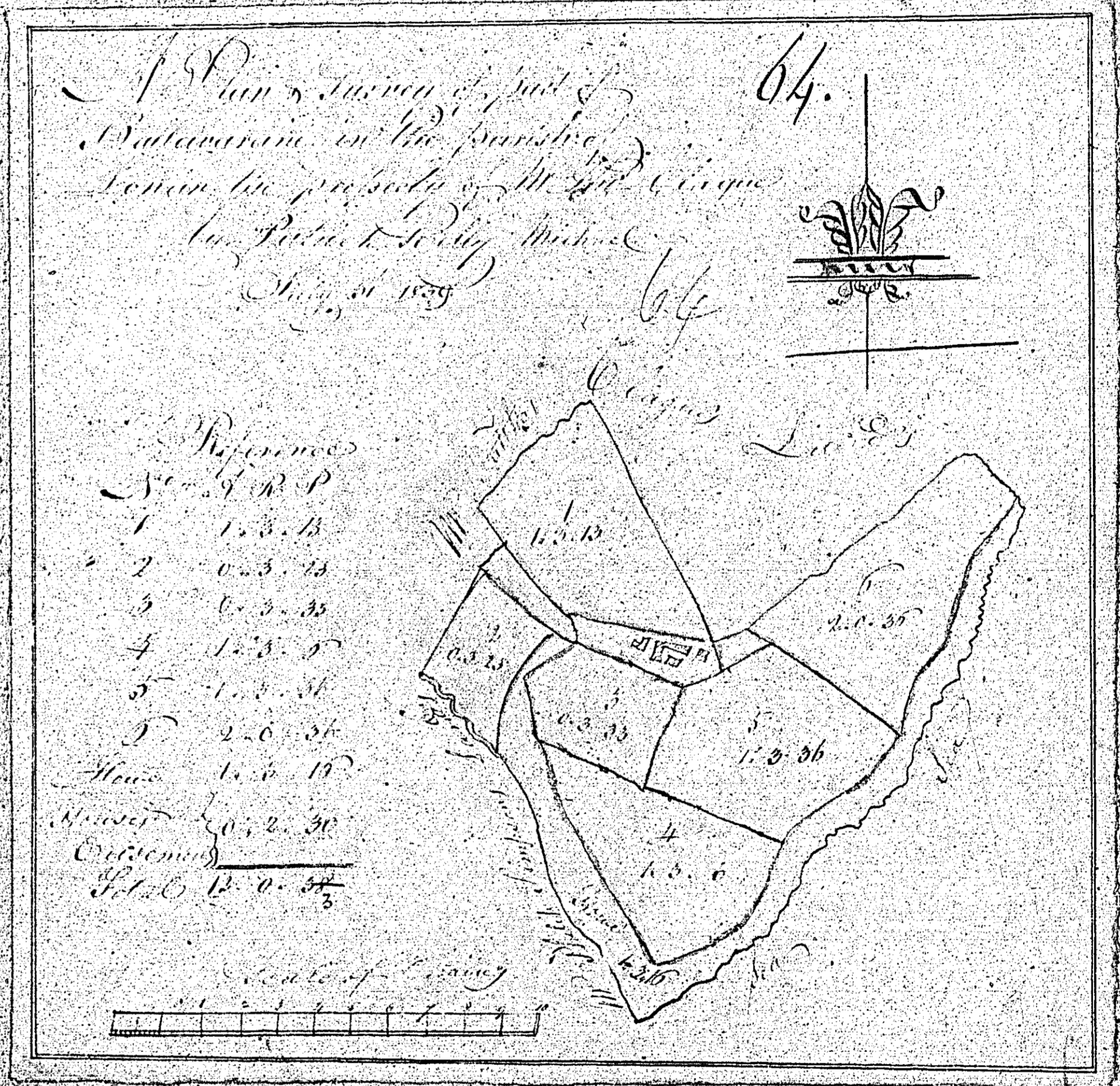

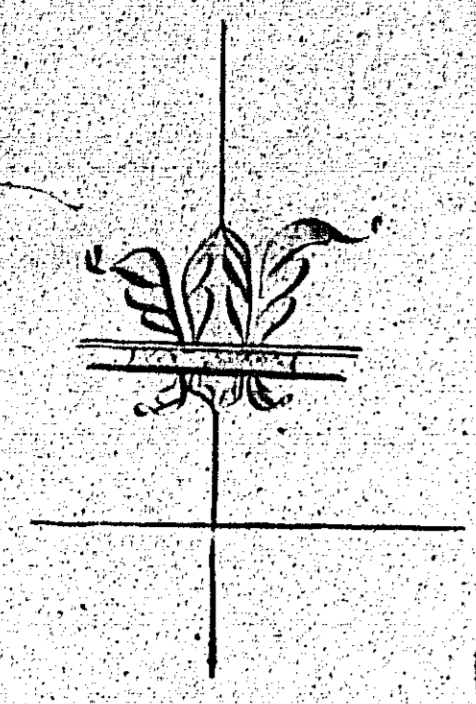

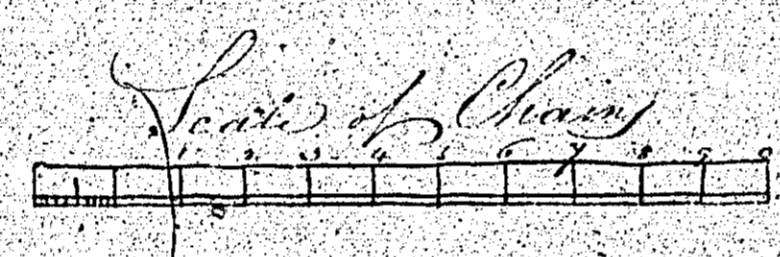
