W. Joseph, Curate.



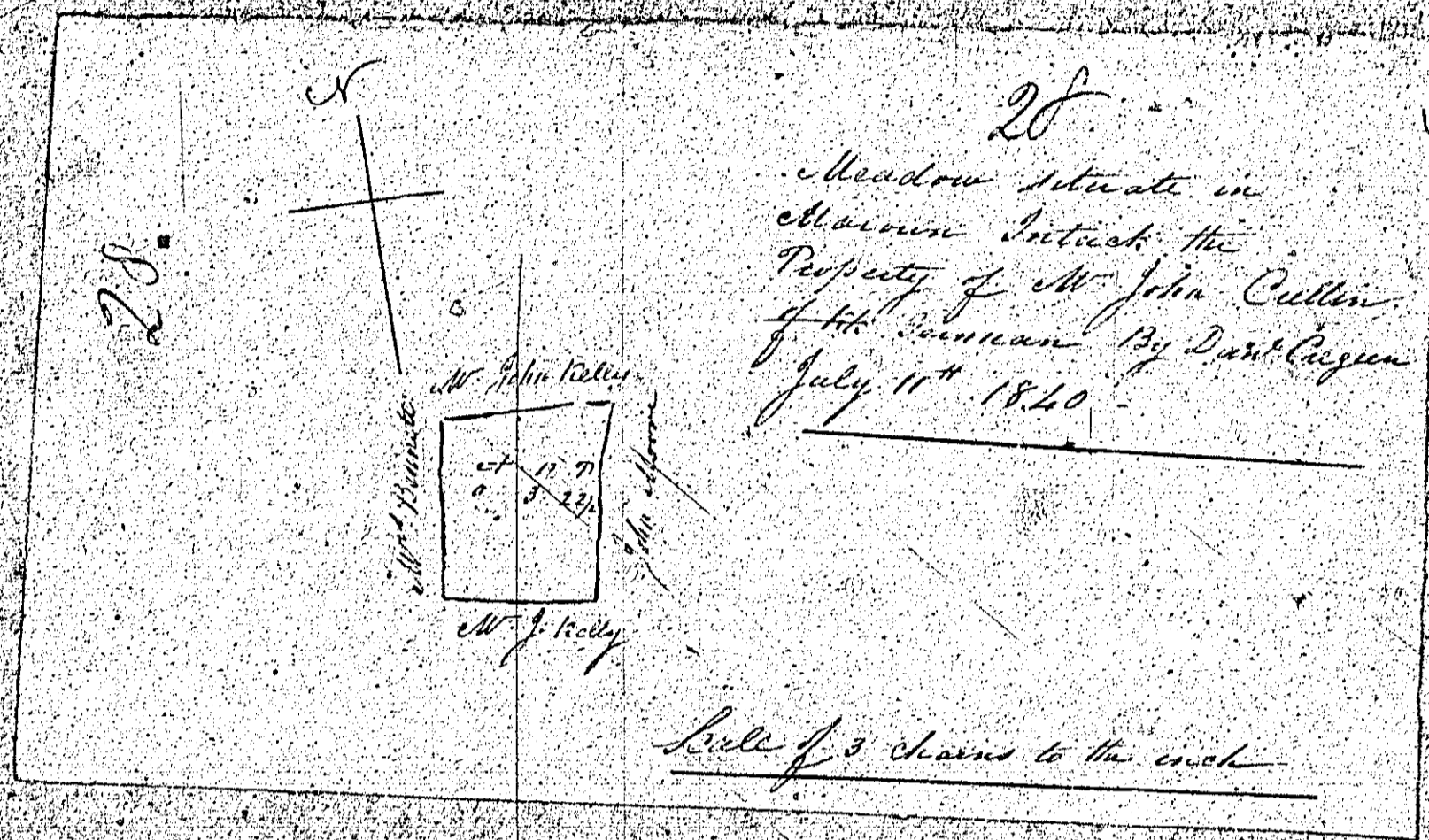

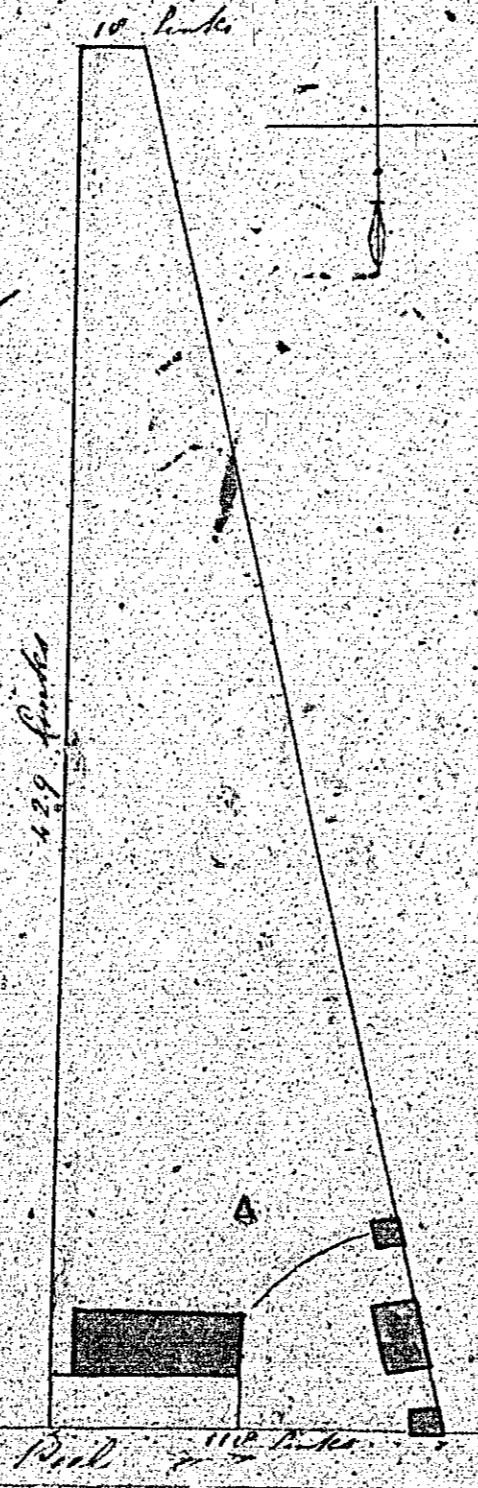


ISLE OF MAN GOVERNMENT: GENERAL REGISTRY

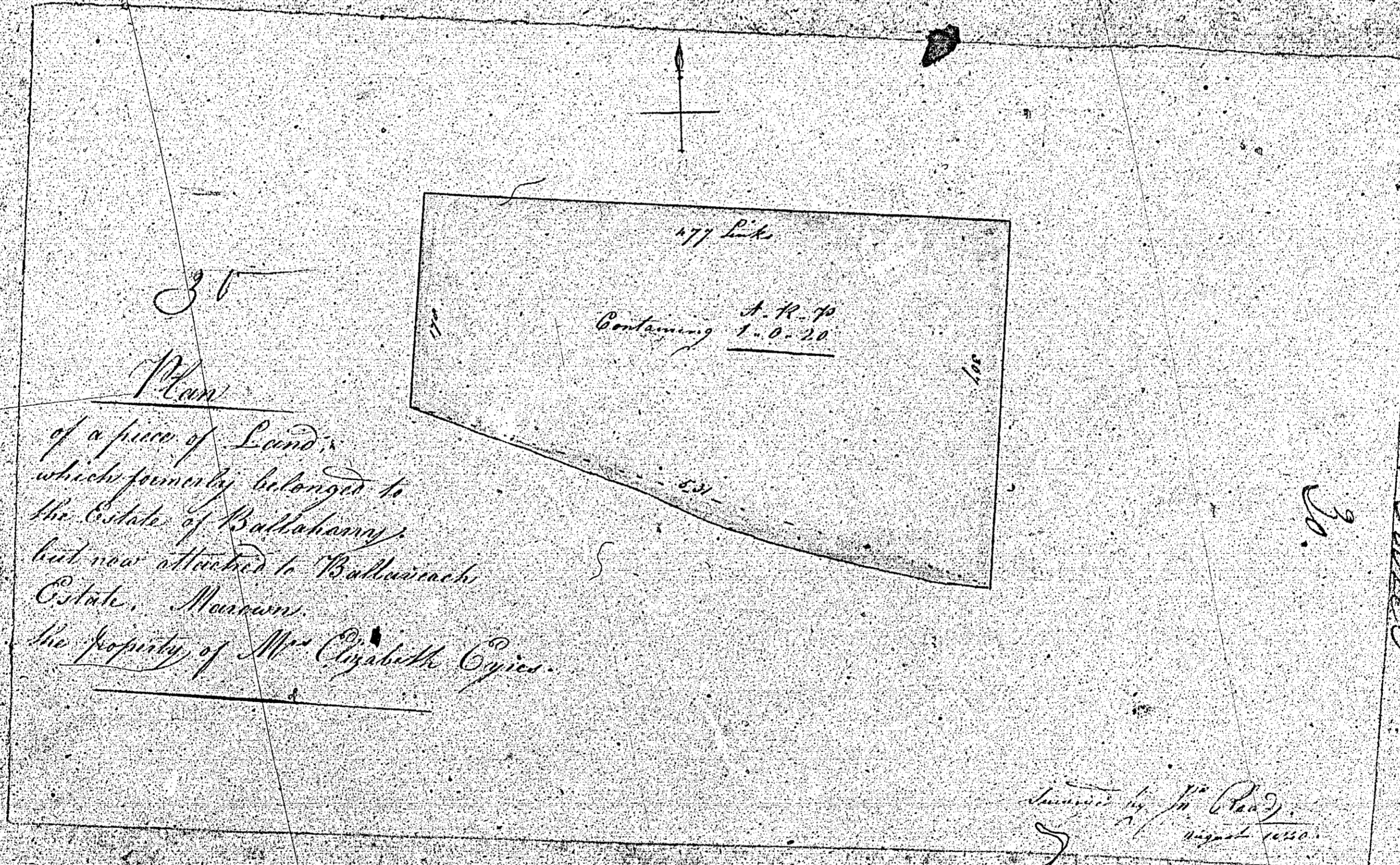
