**Description of series:** Bound minute books containing minutes of the Board of Braddan Parish Commissioners.

Public meetings of the Commissioners were held monthly. Minutes for these meetings can be found in the main sequence of minute books in S114/1. The minutes begin from the establishment of the Commissioners in 1894. The minute books from April 1913 to March 1934 are missing from the sequence and their whereabouts is unknown. The sequence of minutes of meetings of the Commissioners held in private begins in May 1986. The meetings typically discuss personal or sensitive matters that cannot be discussed in meetings attended by the public due to Data Protection legislation.

**Administrative History:** Braddan Parish Commissioners were established in 1894 by provision laid down under the Local Government Amendment Act. Meetings of the Board of Commissioners are held monthly. Minutes in this series were taken during the meetings by the Clerk and were approved and signed at the following Board meeting.

Minutes typically discuss all of the activities and functions of the local authority, including (but not limited to):

- housing;
- rates;
- refuse collection;
- street lighting;
- parks, playgrounds and other leisure facilities;
- property searches;
- environmental health;
- planning applications;
- public information and advice;
- byelaw enforcement; and
- abandoned vehicles.

The local government parish districts roughly correspond to the 17 ancient parishes of the Isle of Man, but exclude those areas which comprise the existing town or village districts.

The members of the Commissioners are elected by the residents of the Parish to administer a range of local government functions and, whenever possible, to represent the Parish by bringing local issues and views to the attention of Central Government and other outside parties. These functions include:

- Housing;
- Refuse Collection;
- Street lighting;
- Parks, playgrounds and other leisure facilities;
- Property Searches;
- Environmental Health;
- Public information and advice;
- Byelaw enforcement; and
- Abandoned vehicles.

Public meetings of the Commissioners are held monthly.

**Custodial History:** The reports and papers in this accession were copies which were sent to and held by Mrs. P. Gelling in her role as a Braddan Commissioner. The papers were passed to the Braddan Parish Commissioner's Office in 2021.
