The Immigration (Isle of Man) (Amendment) (No.3) Order 2020

IMMIGRATION (ISLE OF MAN) (AMENDMENT) (NO.3) ORDER 2020 (APPOINTED DAY) ORDER 2020

The Minister for the Cabinet Office makes the following Order under article 1(2) of the Immigration (Isle of Man) (Amendment) (No.3) Order 2020¹.

1 Title

This Order is the Immigration (Isle of Man) (Amendment) (No.3) Order 2020 (Appointed Day) Order 2020.

2 Interpretation

In this Order –

“**the 2020 Act**” means the Immigration and Social Security Co-ordination (EU Withdrawal) Act 2020² (of Parliament);

“**the No.3 Order**” means the Immigration (Isle of Man) (Amendment) (No.3) Order 2020;

“**the principal Order**” means the Immigration (Isle of Man) Order 2008³.

3 Commencement

- (1) The No.3 Order comes into force as follows.
- (2) Articles 1, 2, 3 and 4 come into force on the day after the day on which this Order is made.
- (3) Articles 5, 6, 9 and 10 come into force on IP completion day⁴.
- (4) Article 7 comes into force as follows –
 - (a) in relation to the extension of sections 1 and 4 of and paragraph 6 of Schedule 1 to the 2020 Act to the Isle of Man subject to the

- modifications in Schedule 10 to the principal Order⁵, it comes into force on IP completion day;
- (b) in relation to the extension of section 2 of the 2020 Act to the Isle of Man subject to the modifications in Schedule 10 to the principal Order, it comes into force immediately before IP completion day; and
- (c) in relation to the extension of sections 5 and 10 of the 2020 Act to the Isle of Man subject to the modifications in Schedule 10 to the principal Order, it comes into force on the day after the day on which this Order is made.
- (5) Article 8 comes into force immediately before IP completion day.
