Qualifications and professional registration	<ul style="list-style-type: none"> Registered healthcare professionals, working within or contracted by the Manx Care, GP practice or Hospice who are permitted staff groups outlined within the current PGD policy Pharmacists must be practising in Manx Care authorised premises i.e. contracted pharmacy premises
Initial training	<ul style="list-style-type: none"> Knowledge of current guidelines and the administration of the drug specified in this PGD/BNF and of the inclusion and exclusion criteria Training which enables the practitioner to make a clinical assessment to establish the need for the medication covered by this PGD Local training in the use of PGDs
Competency assessment	Staff will be assessed on their knowledge of drugs and clinical assessment as part the competency framework for registered health professionals using PGDs
Ongoing training and competency	The registered health care professionals should make sure they are aware of any changes to the recommendations for this medication; it is the responsibility of the registered health care professionals to keep up to date with continuing professional development. PGD updates will be held every two years

7. Clinical Conditions

Clinical condition or situation to which this PGD applies	Seasonal mild rhinitis related to hay fever
Inclusion criteria	Adults and children over 6 years presenting with symptoms of seasonal mild rhinitis related to hay fever
Exclusion criteria	<ul style="list-style-type: none"> • Under 6 years • Recent nasal surgery or untreated nasal infection • Pulmonary tuberculosis • Any known hypersensitivity to any component of the medicine. • Patient refuses treatment under this Patient Group Direction
Cautions (including any relevant action to be taken)	Avoid after nasal surgery (until healing has occurred); avoid in pulmonary tuberculosis; avoid in the presence of untreated nasal infections; patients transferred from systemic corticosteroids may experience exacerbation of some symptoms Systemic absorption may follow nasal administration particularly if high doses are used or if treatment is prolonged; therefore also consider the cautions and side-effects of systemic corticosteroids
Arrangements for referral for medical advice	Patient should be referred to a more experienced clinical practitioner for further assessment
Action to be taken if patient excluded	Patient should be referred to a more experienced clinical practitioner for further assessment
Action to be taken if patient declines treatment	<ul style="list-style-type: none"> • A verbal explanation should be given to the patient on: the need for the medication and any possible effects or potential risks which may occur as a result of refusing treatment • This information must be documented in the patients' health records • Any patient who declines care must have demonstrated capacity to do so • Where appropriate care should be escalated

8. Details of the medicine

Name, form and strength of medicine	Beclometasone Nasal Spray (50micrograms/ metered Spray)
Legal category	Prescription Only Medicine (POM)
Indicate any <u>off-label use</u> (if relevant)	None
Route/method of administration	Intranasal
Dose and frequency	100 micrograms (2 sprays) into each nostril twice daily, reduced to 50 micrograms (1 spray) into each nostril twice daily when symptoms controlled
Quantity to be administered and/or supplied	1 x 200 dose metered spray

Maximum or minimum treatment period	Maximum: Total 400micrograms (8 sprays) daily
Storage	Room temperature
Adverse effects	<ul style="list-style-type: none"> • Altered smell sensation; epistaxis; headache; nasal complaints; taste altered; throat irritation • Glaucoma; nasal septum perforation (more common following nasal surgery); vision blurred • Systemic absorption may follow nasal administration particularly if high doses are used or if treatment is prolonged. Therefore also consider the side-effects of systemic corticosteroids. • MHRA/CSM advice: patients should be advised to report any blurred vision or other visual disturbances – rare risk of central serous chorioretinopathy • If necessary seek appropriate emergency advice and assistance • Document in the individual’s PMR record and inform appropriate doctor/independent nurse prescriber
Records to be kept	The administration of any medication given under a PGD must be recorded within the patient’s medical records

9. Patient information

Verbal/Written information to be given to patient or carer	<ul style="list-style-type: none"> • Verbal information must be given to patients and or carers for all medication being administered under a PGD • Where medication is being supplied under a PGD, written patient information leaflet must also be supplied • A patient information leaflet is available on request
Follow-up advice to be given to patient or carer	If symptoms do not improve or worsen or you become unwell, seek medical advice immediately
