Initial training	<ul style="list-style-type: none"> Knowledge of current guidelines and the administration of the drug specified in this PGD/BNF and of the inclusion and exclusion criteria Training which enables the practitioner to make a clinical assessment to establish the need for the medication covered by this PGD Local training in the use of PGDs
Competency assessment	Staff will be assessed on their knowledge of drugs and clinical assessment as part the competency framework for registered health professionals using PGDs
Ongoing training and competency	The registered health care professionals should make sure they are aware of any changes to the recommendations for this medication; it is the responsibility of the registered health care professionals to keep up to date with continuing professional development. PGD updates will be held every two years

Clinical condition or situation to which this PGD applies	Treatment of Superficial bacterial eye infections
Inclusion criteria	Adult or children over the age of 2 years presenting with bacterial conjunctivitis
Exclusion criteria	<ul style="list-style-type: none"> • Children under the age of 2 years • Hypersensitivity to the active substance or to any of the excipients • Myelosuppression during previous exposure to chloramphenicol • Known personal or family history of blood dyscrasias including aplastic anaemia • Any recent course of treatment (ie. within the last 4 weeks) • Pregnancy • Breastfeeding
Cautions (including any relevant action to be taken)	Do not use with contact lenses
Arrangements for referral for medical advice	Patient should be referred to a more experienced clinical practitioner for further assessment
Action to be taken if patient excluded	Patient should be referred to a more experienced clinical practitioner for further assessment
Action to be taken if patient declines treatment	<ul style="list-style-type: none"> • A verbal explanation should be given to the patient on: the need for the medication and any possible effects or potential risks which may occur as a result of refusing treatment • This information must be documented in the patients' health records • Any patient who declines care must have demonstrated capacity to do so • Where appropriate care should be escalated

Name, form and strength of medicine	Chloramphenicol 0.5% eye drops or 1% eye ointment
Legal category	Prescription Only Medicine (POM)

Route/method of administration	Topical eye drops or ointment

Dose and frequency	<p>To the eye using eye drop Apply 1 drop four times a day for 5 days. For severe infections apply 1 drop every 2 hours for the first 48 hours and then reduce to four times a day for the remainder of the course</p> <p>To the eye using eye ointment Apply daily, to be applied at night (if eye drops used during the day), alternatively apply 4 times a day, if ointment used alone for 5 days</p>
Quantity to be administered and/or supplied	<ul style="list-style-type: none"> • 1 bottle of chloramphenicol eye drops • 1 tube of chloramphenicol eye ointment
Maximum or minimum treatment period	Complete the 5 days course of treatment.
Storage	Store at Room temperature for the eye ointment or in a refrigerator at the temperature between 2 to 8°C for the eye drops
Adverse effects	<ul style="list-style-type: none"> • angioedema • bone marrow disorders • eye stinging • fever • paraesthesia • skin reactions • In the event of untoward or unexpected adverse reactions: If necessary seek appropriate emergency advice and assistance Document in the individual's PMR record and inform appropriate doctor/independent nurse prescriber
Records to be kept	The administration of any medication given under a PGD must be recorded within the patient's medical records

9. Patient information

Verbal/Written information to be given to patient or carer	<ul style="list-style-type: none"> • Verbal information must be given to patients and or carers for all medication being administered under a PGD • Where medication is being supplied under a PGD, written patient information leaflet must also be supplied • A patient information leaflet is available on request • Patients should be advised not to wear contact lenses when they have an eye infection. • Discard container 4 weeks after opening • Seek further advice if any adverse reactions develop • Seek further advice from GP if patient has had repeated eye infections
Follow-up advice to be given to patient or carer	If symptoms do not improve or worsen or you become unwell, seek medical advice immediately
