<b>Qualifications and professional registration</b>	<ul style="list-style-type: none"> <li>Registered healthcare professionals, working within or contracted by the Manx Care, GP practice or Hospice who are permitted staff groups outlined within the current PGD policy</li> </ul>
<b>Initial training</b>	<ul style="list-style-type: none"> <li>Knowledge of current guidelines and the administration of the drug specified in this PGD/BNF and of the inclusion and exclusion criteria</li> <li>Training which enables the practitioner to make a clinical assessment to establish the need for the medication covered by this PGD</li> <li>Local training in the use of PGDs</li> </ul>
<b>Competency assessment</b>	Staff will be assessed on their knowledge of drugs and clinical assessment as part the competency framework for registered health professionals using PGDs
<b>Ongoing training and competency</b>	The registered health care professionals should make sure they are aware of any changes to the recommendations for this medication; it is the responsibility of the registered health care professionals to keep up to date with continuing professional development. PGD updates will be held every two years

<b>Inclusion criteria</b>	<ul style="list-style-type: none"> <li>• Adults presenting with acute severe pain from:</li> <li>• Trauma</li> <li>• Suspected Myocardial Infarction</li> </ul>
<b>Exclusion criteria</b>	<ul style="list-style-type: none"> <li>• Acute abdomen</li> <li>• Acute respiratory depression</li> <li>• Comatose patients</li> <li>• Head injury</li> <li>• Raised intracranial pressure</li> <li>• Risk of paralytic ileus</li> <li>• Delayed gastric emptying</li> <li>• Heart failure secondary to chronic lung disease</li> <li>• Pheochromocytoma</li> <li>• Pregnancy</li> <li>• Known opiate allergy</li> </ul>
<b>Cautions (including any relevant action to be taken)</b>	<ul style="list-style-type: none"> <li>• Adrenocortical insufficiency (reduced dose is recommended)</li> <li>• asthma (avoid during an acute attack)</li> <li>• convulsive disorders</li> <li>• debilitated patients (reduced dose is recommended) (in adults)</li> <li>• diseases of the biliary tract</li> <li>• elderly (reduced dose is recommended) (in adults)</li> <li>• hypotension</li> <li>• hypothyroidism (reduced dose is recommended)</li> <li>• impaired respiratory function (avoid in chronic obstructive pulmonary disease)</li> <li>• inflammatory bowel disorders</li> <li>• myasthenia gravis</li> <li>• obstructive bowel disorders</li> <li>• prostatic hypertrophy (in adults)</li> <li>• shock; urethral stenosis (in adults)</li> </ul>
<b>Arrangements for referral for medical advice</b>	Patient should be referred to a more experienced clinical practitioner for further assessment
<b>Action to be taken if patient excluded</b>	Patient should be referred to a more experienced clinical practitioner for further assessment
<b>Action to be taken if patient declines treatment</b>	<ul style="list-style-type: none"> <li>• A verbal explanation should be given to the patient on: the need for the medication and any possible effects or potential risks which may occur as a result of refusing treatment</li> <li>• This information must be documented in the patients' health records</li> <li>• Any patient who declines care must have demonstrated capacity to do so</li> <li>• Where appropriate care should be escalated</li> </ul>

<b>Route/method of administration</b>	<ul style="list-style-type: none"> <li>Intramuscular Injection</li> <li>Intravenous Injection</li> </ul>
<b>Dose and frequency</b>	<p><b>Once only:</b></p> <ul style="list-style-type: none"> <li>Intramuscular injection: Adult – 10mg</li> <li>Intravenous injection: Adult – Titrate up to <b>maximum</b> 10mg</li> <li><b>Reduce dose in elderly</b></li> </ul>
<b>Quantity to be administered and/or supplied</b>	<ul style="list-style-type: none"> <li>Once only administration of either Intramuscular injection or Intravenous injection</li> <li>For Intravenous injection follow hospital Emergency Department Policy for <b>IV Administration of Opioids for Acute Pain Control in Adults</b></li> </ul>
<b>Maximum or minimum treatment period</b>	<b>Once only</b>
<b>Storage</b>	Room temperature
<b>Adverse effects (continued)</b>	<p><b>Common or very common:</b></p> <ul style="list-style-type: none"> <li>arrhythmias</li> <li>confusion</li> <li>constipation</li> <li>dizziness</li> <li>drowsiness</li> <li>dry mouth</li> <li>euphoric mood</li> <li>flushing</li> <li>hallucination</li> <li>headache</li> <li>hyperhidrosis</li> <li>miosis</li> <li>hypotension (with high doses)</li> <li>nausea (more common on initiation)</li> <li>palpitations</li> <li>respiratory depression (with high doses)</li> <li>skin reactions</li> <li>urinary retention</li> <li>visual impairment</li> <li>vomiting (more common on initiation)</li> <li>withdrawal syndrome</li> </ul> <p><b>Uncommon:</b></p> <ul style="list-style-type: none"> <li>drug dependence</li> <li>dysphoria</li> </ul> <p><b>Parenteral Use:</b></p> <ul style="list-style-type: none"> <li>alertness decreased</li> <li>bile duct disorders</li> <li>mood altered</li> <li>myoclonus</li> <li>sexual dysfunction</li> <li>ureteral spasm</li> <li>urinary disorders</li> <li>vertigo</li> <li>vision disorders</li> </ul> <p><b>Respiratory depression is a major concern with opioid analgesics and it may be treated by artificial ventilation or be reversed by naloxone</b></p>

<b>Records to be kept</b>	The administration of any medication given under a PGD must be recorded within the patient's medical records

<b>Verbal/Written information to be given to patient or carer</b>	<ul style="list-style-type: none"> <li>• Verbal information must be given to patients and or carers for all medication being administered under a PGD</li> <li>• Where medication is being supplied under a PGD, written patient information leaflet must also be supplied</li> <li>• A patient information leaflet is available on request</li> </ul>
<b>Follow-up advice to be given to patient or carer</b>	If symptoms do not improve or worsen or you become unwell, seek medical advice immediately
