	Requirements of registered Healthcare professionals working under the PGD
<b>Qualifications and professional registration</b>	<ul style="list-style-type: none"> <li>Registered healthcare professionals, working within or contracted by the Manx Care, GP practice or Hospice who are permitted staff groups outlined within the current PGD policy</li> <li>Pharmacists must be practising in Manx Care authorised premises i.e. contracted pharmacy premises</li> <li><b>Additional training in management of minor illness regarding assessing and diagnosing patients independently</b></li> </ul>
<b>Initial training</b>	<ul style="list-style-type: none"> <li>Knowledge of current guidelines and the administration of the drug specified in this PGD/BNF and of the inclusion and exclusion criteria</li> <li>Training which enables the practitioner to make a clinical assessment to establish the need for the medication covered by this PGD</li> <li>Local training in the use of PGD's</li> </ul>
<b>Competency assessment</b>	Staff will be assessed on their knowledge of drugs and clinical assessment as part the competency framework for registered health professionals using PGD's
<b>Ongoing training and competency</b>	The registered health care professionals should make sure they are aware of any changes to the recommendations for this medication; it is the responsibility of the registered health care professionals to keep up to date with continuing professional development. PGD updates will be held every two years

## 7. Clinical Conditions

<b>Clinical condition or situation to which this PGD applies</b>	<ul style="list-style-type: none"> <li>• Patient presenting with Acute Otitis Media</li> <li>• Condition not improved following 3 days treatment with analgesia only, otorrhoea noted on examination</li> <li>• Most cases are VIRAL in original and self limiting for 3-7 days</li> </ul>
<b>Inclusion criteria</b>	<ul style="list-style-type: none"> <li>• Patient presenting with Otitis Media</li> <li>• Meets the criteria of the local antimicrobial formulary</li> </ul>
<b>Exclusion criteria</b>	<ul style="list-style-type: none"> <li>• Hypersensitivity to penicillin</li> <li>• Erythematous rashes common in glandular fever and cytomegalovirus infection</li> <li>• Acute or chronic lymphocytic leukaemia</li> </ul>
<b>Cautions (including any relevant action to be taken)</b>	<ul style="list-style-type: none"> <li>• Anticoagulants</li> <li>• Allopurinol</li> <li>• Cytotoxics</li> <li>• Valproate</li> </ul>
<b>Arrangements for referral for medical advice</b>	Patient should be referred to a more experienced clinical practitioner for further assessment
<b>Action to be taken if patient excluded</b>	Patient should be referred to a more experienced clinical practitioner for further assessment
<b>Action to be taken if patient declines treatment</b>	<ul style="list-style-type: none"> <li>• A verbal explanation should be given to the patient on: the need for the medication and any possible effects or potential risks which may occur as a result of refusing treatment</li> <li>• This information must be documented in the patients' health records</li> <li>• Any patient who declines care must have demonstrated capacity to do so</li> <li>• Where appropriate care should be escalated</li> </ul>

<b>Name, form and strength of medicine</b>	<ul style="list-style-type: none"> <li>• Amoxicillin 500mg and 250mg capsules</li> <li>• Amoxicillin Suspension 125mg/5ml and 250mg/5ml</li> </ul>
<b>Legal category</b>	Prescription Only Medicine (POM)
<b>Indicate any <u>off-label use</u> (if relevant)</b>	None
<b>Route/method of administration</b>	Oral
<b>Dose and frequency</b>	<p><b>Child 1 month – 1 year:</b></p> <ul style="list-style-type: none"> <li>• 125mg/5ml three times a day for 5 days</li> </ul> <p><b>Child 1 year – 5 years:</b></p> <ul style="list-style-type: none"> <li>• 250mg/5ml three times a day for 7 days</li> </ul> <p><b>5 years to Adult 500mg:</b></p> <ul style="list-style-type: none"> <li>• as capsules or 250mg/5ml suspension x2 bottles</li> <li>• Three times a day for 7 days</li> </ul>

<b>Quantity to be administered and/or supplied</b>	<ul style="list-style-type: none"> <li>Supply 15 capsules TTO pack or one or two x 100ml suspension</li> <li>According to requirements to complete a 5 day course of treatment at the appropriate dose</li> </ul>
<b>Maximum or minimum treatment period</b>	Maximum 5 day treatment period
<b>Storage</b>	<p><b>Room temperature- Capsules</b></p> <ul style="list-style-type: none"> <li>Reconstitute suspension as directed on container</li> <li>Shake well to ensure uniform mixing</li> </ul> <p><b>Store reconstituted product in a refrigerator.</b></p> <ul style="list-style-type: none"> <li>Add expiry date to pre-packed label</li> <li>Add patient's name and date of issue to pre-packed label</li> </ul>
<b>Adverse effects</b>	<ul style="list-style-type: none"> <li>Diarrhoea; hypersensitivity; nausea; skin reactions; thrombocytopenia; vomiting</li> <li>Diarrhoea frequently occurs during oral penicillin therapy. It is most common with broad-spectrum penicillins, which can cause antibiotic-associated colitis</li> </ul>
<b>Records to be kept</b>	The administration of any medication given under a PGD must be recorded within the patient's medical records

## 9. Patient information

<b>Verbal/Written information to be given to patient or carer</b>	<ul style="list-style-type: none"> <li>Verbal information must be given to patients and or carers for all medication being administered under a PGD</li> <li>Where medication is being supplied under a PGD, written patient information leaflet must also be supplied</li> <li>A patient information leaflet is available on request</li> </ul>
<b>Follow-up advice to be given to patient or carer</b>	If symptoms do not improve or worsen or you become unwell, seek medical advice immediately
