

Extract of Proceedings in the Council of Ministers during January 2020

Part I Decisions made by Council

Enterprise and Opportunity Island We have an infrastructure which supports social and economic wellbeing

Sustainable Vehicle Duty Model

Council considered papers submitted by the Department of Infrastructure and supported the principles for a new, sustainable approach to the charging of vehicle duty, and next steps including the preparation of secondary legislation for submission to Tynwald.

Enterprise and Opportunity Island We have utilities that support our Island communities and businesses

e-llan Communications Ltd Application for Code Powers

Council considered a paper submitted by the Cabinet Office and agreed not to exercise the powers under s10 (5) of the Telecommunications Act 1984 ("the Act") to direct the Communications Commission not to modify e-llan's licence issued under s5 of the Act.

BlueWave Communications Ltd Modification of Licence in relation to 900 MHz

Council considered a paper submitted by the Cabinet Office and agreed not to exercise the powers under s10(5) of the Telecommunications Act 1984 to direct the Communications Commission not to modify the licence issued to BlueWave Communications Ltd.

Wayleaves Bill – Public Consultation

Council considered a paper submitted by the Manx Utilities Authority and agreed that a public consultation be launched in relation to the Wayleaves Bill.

Appointment of Chairman to the Isle of Man Steam Packet

Council considered a paper submitted by the Treasury and agreed the appointment of Mr L Ugland as Non-Executive Director (Chair) of the Isle of Man Steam Packet Group Limited for a period of up to five years, subject to Tynwald approval.

- Transfer of Public Health Functions 2020
- Building (Amendment) Regulations 2020
- Building (Amendment) (No. 2) Regulations 2019

Communications (Television Licensing) (Amendment) Regulations 2020 (of Parliament)

Council considered a paper submitted by the Cabinet Office and agreed that the Communications (Television Licensing) (Amendment) Regulations 2020 (of Parliament) be extended to the Isle of Man.

Competition Bill

Council considered a paper submitted by the Isle of Man Office of Fair Trading and agreed the legislative drafting approach to amendments proposed.

Registration of Electors Bill 2020 - Post Consultation drafting

Council considered a paper submitted by the Cabinet Office and, noting that the consultation results would be published, approved the policy proposals to inform further legislative drafting of the Registration of Electors Bill 2020.

Election (Keys and Local Authorities) Bill 2020 - Post Consultation drafting

Council considered a paper submitted by the Cabinet Office and, noting that the consultation results would be published, approved the policy proposals to inform further legislative drafting of the Election (Keys and Local Authorities) Bill 2020.

OECD Seven Best Practice Principles for the Governance of Regulation

Council considered a paper submitted by the Department of Environment, Food and Agriculture, and agreed that where appropriate, the Island's approach to regulatory governance follows international best practice as set out by the OECD.

Report on Review of Regulatory Functions

Council considered a paper and presentation regarding the review of the regulatory functions, and following participation in a workshop, adopted the ten Key Regulatory Principles, and agreed the recommended proposals for the formation of a new statutory board and regulatory hub.

European Union (Withdrawal Agreement) Bill (of Parliament)

Council considered a paper submitted by the Cabinet Office and noting the purposed of the relevant legislative clause, agreed that the UK's European Union (Withdrawal Agreement) Bill be extended to the Isle of Man.

Extension of Intellectual Property Treaties to the Island

Council considered a paper submitted by the Department for Enterprise and agreed that the Isle of Man Government submits a request to the United Kingdom Government to extend the ratification of following intellectual property treaties to the Island:

- The Budapest Treaty on the International Recognition of the Deposit of Microorganisms for the Purpose of Patent Procedure (1977) as amended on 26 September 1980 [Treaty of Budapest];
- The World Intellectual Property Organisation (WIPO) Copyright Treaty (1996) [WCT];
 and
- The World Intellectual Property Organisation (WIPO) Performances and Phonograms Treaty.
