



Expressions of Interest

Gaiety Theatre Pantomime 2023, 2024, 2025

The Isle of Man Government invites expressions of interest from suitably experienced producers of pantomimes to produce the annual Gaiety Theatre pantomime in 2023, 2024, 2025 for Culture Division, Department of Education, Sport and Culture.

The competitive process will be run as **THREE** lots and producers will be invited to bid for one or more of the three productions. The Department reserves the right to award one or more production(s) to the same producer.

The Department requires a minimum of 18 performances for each production, with a good balance of matinees and evening performance to maximize the impact of the holiday days. Performances cannot start before midday.

No performance will be available on Christmas Day.

Performance Dates

The date ranges available for productions are:

10 December 2023 to 31 December 2023
15 December 2024 to 31 December 2024
14 December 2025 to 31 December 2025

Date ranges include all set up, preproduction prior to public performance, the run of the show and concluding with final get out of all scenery, costumes and props, etc.

School Holiday Dates

The Isle of Man school holidays are yet to be confirmed for 2023/ 2024/ 2025. The Department will advise interested organisations as soon as possible, once the dates are confirmed.

In order to progress to the next stage of the process you will need to 'Opt-In' and complete the 'Form of Acknowledgment' questionnaire and click 'Submit Return' before the Expression of Interest deadline as detailed below.
