HIGHWAYS (ONCHAN WETLANDS, ONCHAN) (DEFINITIVE MAP AND ASSOCIATED STATEMENT) ORDER 2022

Laid before Tynwald: 15 November 2022

Coming into operation: in accordance with article 2.

The Department of Infrastructure makes the following Order under section 92A(2) of the Highways Act 1986.

1 Title

This Order is the Highways (Onchan Wetlands, Onchan) (Definitive Map and Associated Statement) Order 2022.

2 Commencement

This Order comes into operation on the day after it is made¹.

3 Interpretation

In this Order, the “**new highway**” means the length of footpath dedicated as a public right of way connecting the village green and C1101, in the Parish of Onchan, and which is shown by a solid red line on the map in the Schedule.

4 Amendment to the definitive map and associated statement

- (1) The definitive map is amended by indicating on the definitive map using a solid green line that the new highway has been created and marked “683”.
- (2) The associated statement in respect of the highway is amended as follows.
- (3) After the entry numbered 682, insert —

¹ Under section 92A(7) of the Highways Act 1986, an order made under section 92A(2) which does no more than give effect to an agreement under section 87 of that Act must be laid before Tynwald as soon as practicable after it is made. This Order gives effect to the Deed of Dedication between Manx Wildlife Trust and the Department of Infrastructure dated 26 October 2021, which was made under section 87 of the Highways Act 1986.

683. SC40SW The Onchan Wetlands Footpath starts at 60m
Grid Reference SC 401782, Buttermere Drive (C1101) and skirts around the southern section of Manx Wildlife Trust's Onchan Wetlands (Curragh Kiondroghad) to SC 400782 Faaie Chiondroghad (Onchan Village Green). The Public Right of Way is designated as a footpath with a width of 1.5 metres.

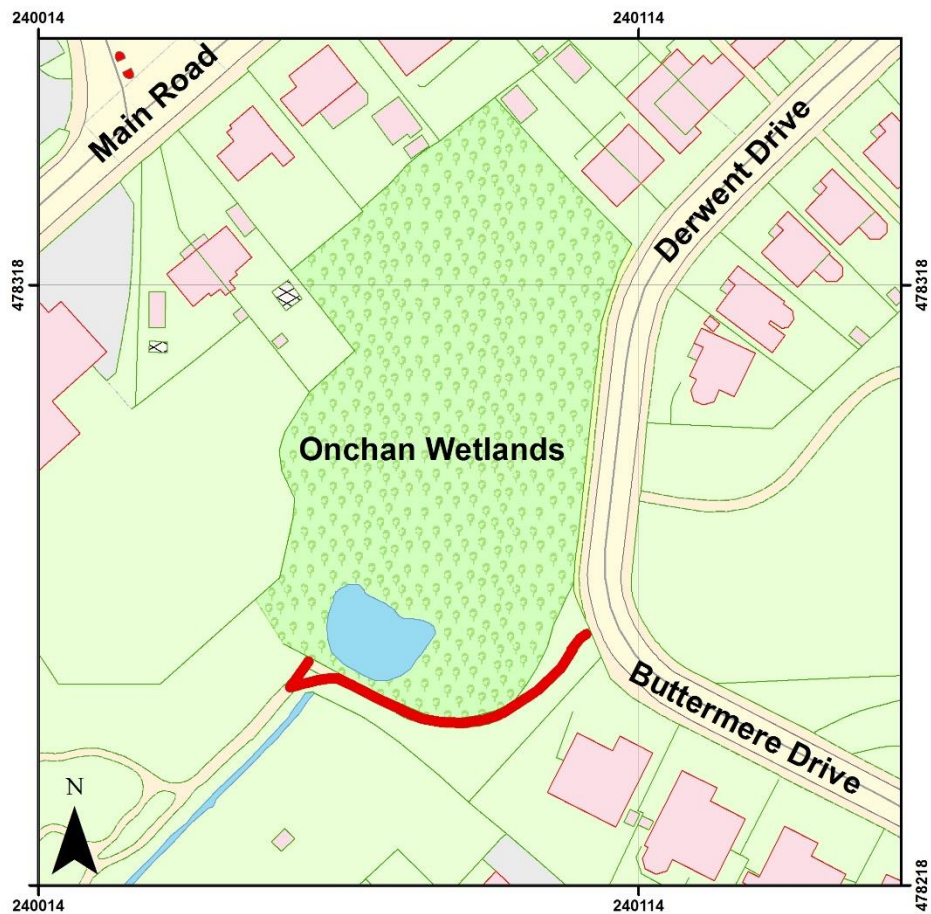

EXPLANATORY NOTE***(This note is not part of the Order)***
