# HIGHWAYS (PULROSE GOLF COURSE, DOUGLAS) (DEFINITIVE MAP AND ASSOCIATED STATEMENT) ORDER 2022

Laid before Tynwald: 15 November 2022 Coming into operation: in accordance with article 2.

The Department of Infrastructure makes the following Order under section 92A(2) of the Highways Act 1986.

### 1 Title

This Order is the Highways (Pulrose Golf Course, Douglas) (Definitive Map and Associated Statement) Order 2022.

### 2 Commencement

This Order comes into operation on the day after it is made 1.

### 3 Interpretation

In this Order, the "new highway" means the cycle-path —

- (a) that begins at an entrance from the A5, New Castletown Road at, GR 235867E 475631N, and runs in a south-easterly direction for approximately 3.5 metres at a width of 3 metres;
- (b) that turns, running in a north-easterly direction, for approximately 187 metres, to GR 236020E 475739N, at which point it branches into two cycle-paths;
- (c) that includes a short spur that runs north-easterly for approximately 16 metres at a width of 3 metres, exiting at GR 236034E 475750N onto the C747, Spring Valley Road;

- (d) the main branch of which turns in a south-easterly direction running for approximately 176 metres at a width of 3 metres; and
- (e) that turns north-easterly, for approximately 24 metres and exits onto the C729, Springfield Road, GR 236209E 475689N,

and which is shown by a solid blue line on the map in the Schedule.

### 4 Amendment to the definitive map and associated statement

- (1) The definitive map is amended by indicating on the definitive map using a solid green line that the new highway has been created and marked "682".
- (2) The associated statement in respect of the highway is amended as follows.
- (3) After the entry numbered 681, insert —

**™**682. SC37NE

Pulrose Golf Course Cycle-path starts at an entrance from the A5, New Castletown Road, SC 358756, and runs north-east, along the side of the Pulrose Golf Course. At SC 360757 it branches into two cycle-paths. A short spur runs north-east, exiting at SC 360757 onto the C747, Spring Valley Road. The main branch turns south-east, and runs along the side of the football pitches, at the back of the houses on Springfield Road. The cycle-path ends at the exit onto the C729, Springfield Road at SC 362756.

The Public Right of Way is designated as a cycle-path with a width of 3 metres, over which the public have a right of way on pedal cycles and a right of way on foot.


