## Notes

### **Payment Methods.**

Please make cheques payable to Isle of Man Post Office

All Postal applications must be accompanied by a cheque or postal order and not cash.

Payment at the counters may be paid by: Cheque, Cash, Debit Cards or postal orders.

### **Place of Payment**

All other applications will require to be handed in at the nearest Post Office or post to: Isle of Man Post, Licensing Agent, PO Box 367, Douglas, Isle of Man, IM99 3HA. Contact number 698525

### **Dishonoured Cheques.**

If a cheque for a licence is dishonoured, the licence will be void from the date of issue and the vehicle will become unlicensed.

### **Vehicles requiring Certificates from Vehicle Test Centre Tromode.**

- a. Hire and Drive vehicles over 3 years old.
- b. Taxis.
- c. Buses or minibuses over 6 months old (category D and D1 whether or not they are used to carry passengers for hire or reward). If the vehicle is to be used for carrying passengers for hire or reward a certificate of initial fitness is also required.
- d. Vehicles previously licensed in the Isle of Man and which have had no licence in the last 2 years.
- e. Vehicles that have been scrapped, written-off or seriously damaged and taken out of use but have been subsequently repaired.
- f. A goods vehicle exceeding a maximum gross weight of 3,500kg.

If a certificate is required, please book the vehicle into the Test Centre at least 1 month prior to expiry of your present licence. Vehicle Test Centre contact number 627431.

### **Plating Certificate**

A plating certificate for vehicles over 3,500 Kg is required.

### **Insurance Certificate.**

A valid Insurance Certificate is required.

### **When to use form VL1.**

If the goods vehicle is not used commercially to carry or haul goods.

To register draw-bar trailers exceeding 2000Kg maximum laden weight.

### **Number of axles**

If the vehicle is being used to draw a 3 axle trailer ONLY then this should be declared on the front of this form. You must notify the Post Office Licensing Office immediately if you change the trailer being drawn as this may affect the rate of duty payable.

### **Type of Duty Payable**

CO<sub>2</sub> only applies to B category vehicles ie cars, small vans and small motorhomes.

CO<sub>2</sub> Duty will only be chargeable if the data is present.

- Vehicles registered before the 1<sup>st</sup> April 2010 will be charged the lower rate of Duty based on CC or CO<sub>2</sub>.
- Vehicles registered from 1<sup>st</sup> April 2010 will be charged Duty based on CO<sub>2</sub>.

### **6 Month Duty payment option**

6 month duty is calculated by taking the 12 month duty rate and dividing by 2 then adding £6.00

### B Category

**Note:** An articulated vehicle may not exceed a laden weight of 44,000Kg unless the vehicle is so authorised as a special type under paragraph 3 of schedule 2 to the road traffic act 1985.

Vehicles >7,500Kg will receive:

- a. 25% discount of payable duty if Euro Status 4 – manufactured between 01/10/2006 – 30/09/2009
- b. 50% discount of payable duty if Euro Status 5 – manufactured between 01/10/2009 onward.
