# Isle of Man Public Record Office

**Administrative History:** Lonan Parish Commissioners was established on 9 October 1894 under the terms of the Local Government Act 1886. The first meeting took place at the infants school room, Laxey Glen on 13 October 1894. The local authority is essentially a rural authority extending from Onchan in the south towards Snaefell in the east and Maughold in the north. In 1895 the village of Laxey was created as a result of the miners wanting their own church and a separate local authority and so Laxey Parish Commissioners, was created.

Lonan Parish Commissioners ceased to exist in May 2016, after the merger of Lonan, Laxey and Maughold Commissioners to become Garff Parish District Commissioners under the Garff (Local Government District) Order 2015 - SD/2015/0362.

**Custodial History:** The records in A69 were created by Lonan Parish Commissioners. Records were stored at the office of the Clerk of the Lonan Parish Commissioners (35 New Road, Laxey) prior to the transfer to IOMPRO on 13 May 2016. Angela Skitt, IOMPRO examined paper records at the office and selected those suitable for permanent preservation. The Clerk (Peter Hill) also maintained some digital records which have been transferred to IOMPRO as a temporary consignment pending further processing and selection. Some digital and paper records which were still required for administrative purposes were transferred by the Clerk of Lonan Parish Commissioners to the new Clerk of Garff Parish District Commissioners.

The records of A236 were deposited with MNH by W G Gale, Clerk to Lonan Parish Commissioners, 17 January 1996. No closure periods were documented for access purposes at the time of deposit nor were terms of deposit specified but it is taken by MNH staff that it was a long term loan. Descriptive lists and sub-numbering were prepared by Roger Sims, Librarian Archivist in 1996. Another early minute book was deposited in 1998 with MNH and an accrual of 2 parish rate books and 2 cash books were received by Roger Sims also on 20 October 1999 and his list was subsequently amended; this was later amended again by Wendy Thirkettle at MNH for ease of accurate recording. No closure periods were documented for access purposes at the time of deposit. Permission was given by MNH Trustees on 5 September 2019 for several deposits of public records, including deposit MS 09797, to be transferred from MNH to the PRO in order to rationalise holdings between the two Manx archival repositories. The records were transferred to IOMPRO on 10 May 2022. Rachel Johnstone, Records & Archive Officer.

**Appraisal:** A69 was selected for permanent preservation by Angela Skitt, IOMPRO in April 2016. A small number of duplicate items and low level administrative correspondence were weeded after accession and were disposed of on 13 November 2020 with the written authority of Peter Burgess, Clerk to Garff Commissioners (the successor body to Lonan Commissioners after the merge of local authorities in April 2016).
