Introduction

The Quarterly Statistical Report draws data and indicators relating to the performance of the Isle of Man economy together from a range of sources across and outside the Isle of Man Government.

Prior to 2020, the need for such a report was met by the then Economic Affairs Division's Quarterly Economic and Statistical Report. Publication of that report was temporarily discontinued during the COVID-19 pandemic due to much of the material produced in the report being made available via the Government's Economic Recovery Group dashboard. As that source of data is now no longer in operation, and in response to requests from members of the public and the Isle of Man Government, Statistics Isle of Man has made the decision to launch the Quarterly Statistical Report to perform a role similar to that of the Quarterly Economic and Statistical Report.

The Quarterly Statistical Report is currently under development. At present it borrows heavily from the Quarterly Economic and Statistical Report in structure and content. Statistics Isle of Man will be reviewing its content in order to enhance and improve the report's coverage and improve its usefulness to both Government and the public.

It was intended that this quarter's report would contain some provisional estimates from the population model currently under development by Statistics Isle of Man. However, due to the closeness to the publication for the main population report and a desire to further improve the data, such provisional estimates will instead start in next quarter's report.

Key Points

This report provides the latest available information as at 30 September 2023. Some of the key points from the report are as follows:

- The number of people in employment was 36,574, whilst that of those in selfemployment was 7,913.
- Inflation for the 12 months to September 2023 was 5.7% as measured by the Consumer Price Index (CPI). This is 1.2% lower than at the end of June 2023, and 4.1% lower than at the same time last year.
- The number of people registered as unemployed was 256, which is 28 more than at the end of June 2023.
- There were 447 full time job vacancies and 286 part time job vacancies available at the end of September 2023. Overall these figures are lower than both the previous quarter and at the same time last year.
- The average house price at the end of September 2023 was £386,647, which is lower than the June 2023 average of £391,735, and just 0.5% higher than the same time last year.
- 363 new work permits and 77 renewals were issued in the three months to September 2023. It should be noted however that work permits will be impacted when exemptions to certain jobs or sectors are applied or removed. 188 new national insurance numbers were issued to foreign nationals, which includes anyone outside of the United Kingdom.
- There was a total of 794 ships registered on the Isle of Man with a total registered tonnage of 12 million tonnes. There are 6 less ships registered than at the end of September 2022.
- The total deposit base was £40.25bn as at 30 June 2023, which is the latest available data, and this is down from £41.04bn at the end of March 2023.
- Funds under Management amounted to \$13.41bn as at 30 June 2023, which is the latest available data, and this is up from \$13.12bn at the end of March 2023.






Equities - FTSE 100






Bank of England Base Rate Projection




Inflation as at September 2023 stands at 5.7% for CPI and 8.6% for RPI.






Isle of Man Property Market – Prices compared to 12 months ago



For the 12 months to September 2023, the average house price was £386,647, a flat was £197,891 and the weighted property price was £344,918. The weighted property price is a weight average of house and flat prices based on transaction volumes.

For the 12 months to September 2023, 1,037 houses and 269 flats were sold.


All property market data is based on the latest available data from the Land Registry. There is a time lag in transactions being registered with the Land Registry, which is reflected by the difference shown between the first estimate, which is taken at the end of the applicable quarter and the later estimates which include transactions which were not lodged until after the first estimate was produced. Data is revised for up to 12 months after the first estimate has been published, after which point the data is considered final.




Planning Approvals and Building Control

12 Month Rolling Average Electricity Consumption (Units Consumed '000s)




For the three months to September 2023, 30.8 million units of electricity were consumed domestically and 44.6 million units were consumed for non-domestic purposes.








Registered Ships

As at September 2023, there were 794 ships registered on the Isle of Man, and the registered tonnage during the quarter to the end of June 2023 was 12.0 million tonnes.


The Registered Tonnage figures have been adjusted as there have been some errors over many years of reporting the figures manually. A new reporting system has been adopted resulting in more accurate figures.






The Persons Employed and Self-Employed data will include a number of individuals who are both employed and self-employed.

Unemployment




As at September 2023, 256 individuals were registered unemployed, which is 28 more than in June 2023, but 51 less than at the same time last year. There are 21 individuals who have been unemployed for 12 months or more, and the 12 month average number of unemployed people is 270.





Annual Changes in Employment by Sector for Seasonal Industries






Job Vacancies



At the end of September 2023, there was a total of 733 job vacancies at the Job Centre. Of these, 447 were full time vacancies and 286 part time vacancies.

For the three months to September 2023, there were 363 new work permits issued, 77 renewals, and 188 national insurance numbers were issued to foreign nationals over the same period.






The total funds under management as at June 2023 is \$13.4 billion.




Financial Services Act 2008 Licence Holders

New Company Formation




During the quarter to September 2023, 210 1931 Act companies were formed, 147 2006 Act companies were formed and 24 companies converted to 2006 Act companies.




Total Registered Companies
