description

The small rectangular cottage is constructed of stone cement rendered with a thatched roof (rushes from the Ayres). Set at right angles to the road the structure is somewhat renovated but maintains the same original rectangular windows on either side of the single front door. There is a minor extension to the east with a slate roof and another door.

No interior inspection has been performed.

The cottage appears in good repair.

recommendation

This cottage is situated within a hundred yards of another of similar type. Having two such examples of the few remaining buildings of this early rural workers dwelling close together and adjacent to a public road lends weight to their listing for preservation. Nowever this cottage would be better with the minor roof also that ched.
