Competency assessment	Staff will be assessed on their knowledge of drugs and clinical assessment as part the competency framework for registered health professionals using PGDs
Ongoing training and competency	The registered health care professionals should make sure they are aware of any changes to the recommendations for this medication; it is the responsibility of the registered health care professionals to keep up to date with continuing professional development. PGD updates will be held every two years

Exclusion criteria	<ul style="list-style-type: none"> Children under the age of 2 years Known hypersensitivity to the preparation Application to eyes, anogenital region, and broken or infected skin Application to face (1% cream only) Skin lesions caused by infection ie, cold sores, chicken pox, acne, athlete's foot, ringworm or impetigo

Cautions (including any relevant action to be taken)	<ul style="list-style-type: none"> • Pregnancy – inadequate evidence of safety • Prolonged use on the face is not recommended <p>A detailed list of cautions is available in the SPC, which is available from the electronic Medicines Compendium website: www.medicines.org.uk and BNF https://bnf.nice.org.uk</p>
Arrangements for referral for medical advice	Patient should be referred to a more experienced clinical practitioner for further assessment
Action to be taken if patient excluded	Patient should be referred to a more experienced clinical practitioner for further assessment
Action to be taken if patient declines treatment	<ul style="list-style-type: none"> • A verbal explanation should be given to the patient on: the need for the medication and any possible effects or potential risks which may occur as a result of refusing treatment • This information must be documented in the patients' health records • Any patient who declines care must have demonstrated capacity to do so • Where appropriate care should be escalated

Quantity to be supplied	<ul style="list-style-type: none"> • 1 x 15g tube <p>Notes on application: The length of cream equivalent to one fingertip unit (the distance from the tip of an adult index finger to the first crease) is sufficient to cover an area that is twice that of the flat adult hand</p>
Maximum or minimum treatment period	<p>Maximum: No longer than 1 week</p> <ul style="list-style-type: none"> • 2-3 days for insect bites • 5-7 days for conditions such as allergic contact dermatitis • If the condition worsens or symptoms persist after one week seek further advice
Storage	Room temperature
Adverse effects	A detailed list of adverse reactions is available in the SPC, which is available from the electronic Medicines Compendium website: www.medicines.org.uk and BNF https://bnf.nice.org.uk
Records to be kept	The administration of any medication given under a PGD must be recorded within the patient's medical records

8. Patient information

Verbal/Written information to be given to patient or carer	<ul style="list-style-type: none">• Verbal information must be given to patients and or carers for all medication being administered under a PGD• Where medication is being supplied under a PGD, written patient information leaflet must also be supplied• A patient information leaflet is available on request• Advise to apply sparingly to the affected area
Follow-up advice to be given to patient or carer	If symptoms do not improve or worsen or you become unwell, seek medical advice immediately
