# REGISTRATION OF MARRIAGES (FEES) REGULATIONS 2023

Approved by Tynwald: 22nd November 2023 Coming into operation in accordance with regulation 2

The Treasury makes the following Regulations under section 51(5) of the Marriage Act 1984.

#### 1 Title

These Regulations are the Registration of Marriages (Fees) Regulations 2023.

#### 2 Commencement

If approved by Tynwald, these Regulations come into operation on 1 April 2024<sup>1</sup>.

#### 3 Fees

The fees payable under the Marriage Act 1984 are prescribed in the table in the Schedule as follows —

- (a) column 1 specifies the provision of the Marriage Act 1984 under which a matter arises for which a fee is payable;
- (b) column 2 specifies the matter in respect of which a fee is payable;
- (c) column 3 prescribes the fee in respect of the matter described in the corresponding row in column 2.

#### 4 Revocation

The Registration of Marriages (Fees) Regulations 2016<sup>2</sup> are revoked.
