How to submit an enquiry

If you need to contact Customs & Excise about your indirect tax account, returns and/or payments you can send messages using the Online Portal.

Login to Online Services; go to Customs & Excise and select Online Portal.

On your homepage you can use the toolbar, click on **Inbox** and select **New Message**.
