## Guidance

Voting by post is an easy and convenient way of voting if you are unable to visit your allotted polling station. It is also available to those who choose not to vote in person. Postal votes can be sent to addresses in the Isle of Man, UK and overseas. You must be 16 years old or over on polling day and registered on the electoral register in order to vote. The closing date for the receipt of postal voting applications is:

If the postal ballot paper is to be marked within the Isle of Man - 08 May 2024

If the postal ballot paper is to be marked within the British Isles, but outside the Isle of Man - 02 May 2024

If the postal ballot paper is to be marked overseas (outside the Isle of Man and the British Isles) - 23 April 2024

Make sure you complete all sections of the application form and supply your date of birth and signature. Your date of birth and signature are needed on this application form, and again when you use your postal vote. This information is needed to prevent fraud.

You will be sent a postal ballot pack containing two envelopes ('A' and 'B'), a postal voting statement and a ballot paper featuring your unique identification number.

### When you get your postal ballot pack:

- Put it somewhere safe
- Don't let anyone else handle it

#### When you return your postal vote:

- Take it to the post box yourself, if you can
- If you can't do that, either give it to somebody you know and trust to post it for you
- Don't hand it to a candidate
- Don't leave it where someone else can pick it up

A pre-paid envelope is included in your postal ballot pack. However, if you are sending it from overseas, you may need to pay the postage.

## **Privacy Notice**

The Cabinet Office collects and processes personal information to fulfil its legal and statutory functions.
