

PAYMENT/SUBMISSION OF APPLICATION

Every application to replace a current Licence on its expiry must be accompanied by a fee of £41.00, providing it is made by the date of expiry. Otherwise, the fee for a new Licence is £65.00.

On completion of the application form, take or send it to the Road Transport Licensing Committee, Thie Slieau Whallian, Foxdale Road, St John's, IM4 3AS.

Payment can be made via credit or debit card, in cash or by cheque, made payable to "Isle of Man Government". Please do not postdate your cheque — it will not be accepted. If you underpay, your application will be rejected and returned to you. Please write your full name and address on the reverse side of the cheque. If you are sending your application form by post, please do not include cash.

TYPE OF LICENCE APPLIED FOR

In each case, the Licence authorises the operator to Ply for Hire throughout the District or Districts specified on the licence.

A Ply for Hire Service Licence, when granted, will be issued for 5 years as per section 12(2) of the Road Transport Act 2001. Annual Operator Discs will be issued for each vehicle covered by the Licence. The annual fee for the Operator Disc is currently £118.00.
