

PRIOR INFORMATION NOTICE

Provision of online educational, clinical and support services for prescribers

Manx Care (a Statutory Board of the Isle of Man Government) ("**the Board**") was established in April 2021 by the Isle of Man Government as an arm's length organisation, to focus on delivery of health and social care services on the Island.

Manx Care now wishes to explore options for services available online to assist Manx Care's prescribing staff to improve both quality and safety when prescribing

Manx Care would be interested in parties who can provide services such as:

- Online training and webinars for prescribers
- Access to benchmarking data and analysis tools
- Latest news and releases for prescribers
- Experience sharing and best practice

Responding to this Prior Information Notice

Interested parties are invited to submit a brief summary of their experience, capability and proposed solution.

The provider will need to demonstrate that they can provide online resources, specifically relating to pharmacy and medicines optimisation within primary care.

These resources should be aimed at providing pharmacy teams with evidence, data and tools which enable cost-saving and patient safety initiatives.

In addition, the provider should be able to provide educational resources to support a pharmacy team's professional development.

The provider should be able to use prescribing data from across England and the Isle of Man and allow manipulation of this data via online searches and analysis to support pharmacy teams e.g. identifying areas of high spend.

Please include an indicative cost for access to these resources.

By responding to this request it must be understood that, at this stage, the Board are only exploring options, no commitment is intended or implied and this request may or may not progress through to a competitive tender exercise. An invitation to tender may follow this Request for Information, but the Board is not under any obligation to issue invitations to responders to this Request.
