Policy and Guidance on Admission to Secondary Schools

Reviewed March 2012

The purpose of this document is to clarify the basis and procedures by which pupils of secondary school age may be admitted to an Island secondary school.

Principle

The secondary school attended will normally be determined by the parents'* place of permanent residence as given on the Electoral Roll and at the Isle of Man Government's Treasury Rates Office. (* all references to parents also include legal guardians.)

In the case of families living apart, "parents' place of permanent residence" shall, in all cases, be taken to be the place of permanent residence of the parent with whom the child normally resides during the period Monday - Friday when schools are open.

Policy - Transfer from Primary School to Year 7

- The Island's 35 primary schools have clearly defined catchment areas and it is the geographical boundaries of groups of these catchment areas, which define the areas served by secondary schools.
- Each child's parents' home (permanent place of residence) may be identified, therefore, with its 'natural' secondary school by reference to its location relative to its local primary school.
- It is the Department's policy that each child should attend his or her 'natural' secondary school. **If the child has attended an out of catchment area primary school, this will not confer the right to attend at a later stage the associated secondary school.**
- Each secondary school has a specialist department, which can support children with special educational needs. If a child has a severe learning difficulty (identified at School Action or School Action + within the Department's procedures) to such an extent as needing education mainly in a special unit, the same policy shall apply.
- Secondary schools and their associated primary school catchment areas are summarised in Appendix A.
 - Siblings may attend a different secondary school from the one naturally associated with their parents' place of residence if an older brother or sister is still on the roll of the different secondary school on the day that the younger child starts his/her attendance.
 - Each secondary school will be responsible for making such offers for surplus places. Any such offers will be made in March and April each year.

The Department of Education and Children will act as the appellate body in the event of any disputes or appeals. Any appeals should be addressed in writing to the Minister for Education and Children and will be -

- considered until the end of May when the process should be finalised.
- A form (AP3) will be available to parents of year 6 primary school pupils from their primary school headteacher in February of each year. This form is for parents to indicate:
 - the confirmation of their natural secondary school;
 - their wish to register an interest in their child attending a secondary school **other** than their natural one(s).

Parents are asked to return the form to their primary school headteacher by the end of February, otherwise it will be assumed that their children will attend the natural secondary school for their area.

Policy - Admission to Secondary School in Years 8-13

Pupils whose parents' home (permanent place of residence) is in the secondary school's natural catchment area will automatically be accepted on to the roll of that school when parents register with the school.

If an 'out of catchment area' pupil is admitted, siblings of that pupil may also be admitted.

Review

The Department of Education and Children reviews its procedures at regular intervals in order to ensure that the availability of secondary school places is both efficient and fair.

*****Pupils transferring from the Bunscoil Ghaelgagh whose parents wish them to continue with an element of Manx medium learning are for these purposes, regarded as residing within the catchment area of the Queen Elizabeth II High School, Peel, irrespective of the parents' actual place of permanent residence, provided that the pupil has been in attendance at the Bunscoil for more than one year prior to attaining secondary school age.**
